It was unanimously agreed to recommend refusal due to the rural location not being suitable for industrial use. Land was designated in the parish for such use and Local Plan Policy E10 states that applications for new industrial and commercial development in the countryside would not be permitted unless an overriding need to be located away from towns and villages can be demonstrated. There was no evidence of such a need in this location. The Planning Inspectorate's Appeal Decision Ref: APP/W3520/W/22/3304859 should be referred to for supporting information.

- b. There were no planning determination to note it was noted that Planning Inspectorate Appeal Reference APP/W3520/W/22/3304859 made against Mid Suffolk District Council's refusal of an outline application for the erection of 4 commercial unites (B2) and three dwellings had been dismissed. Brome Grange.
- c. Other planning matters the Clerk reported the application for the B-17 memorial in the grounds of the Oaksmere still had not been determined and MSDC Planning had asked for further details of the materials to be used.
- 6. Diss and District Neighbourhood Development Plan

The recent referendum had seen an 18% turnout of which 85% voted in favour of the Plan. A date would need to be set for adoption of the Plan.
