Minutes of Meeting of Brome and Oakley Parish Council held at 7.30 pm on **Monday 10 October 2022** at Brome and Oakley Village Hall.

PRESENT: Councillors Roger Broughton, Kelly Keeley, Tom Pace, John Parry and Mark Prior. Also in attendance the Clerk, County Councillor Jessica Fleming and District Councillor David Burn.

- 1. <u>Apologies for absence</u> Apologies were received from Cllrs Halton and Demanget and accepted by the Council. Apologies were noted from Cllr Doe after the meeting had taken place.
- 2. <u>Declarations of pecuniary and other interests from members on any item to be discussed and requests</u> for dispensations

All councillors in attendance declared a non-pecuniary interest in matters relating to the Village Hall 3. Public Forum

<u>County Councillor Jessica Fleming</u> – had provided a report ahead of the meeting and took questions on 'warmer home' initiatives.

<u>District Councillor David Burn</u> – had provided a report ahead of the meeting. He then provided additional information on CIL funding bids.

Agenda item 9 was considered at this point in the meeting.

9. Highways

- a. To consider the Suffolk Highways traffic calming schemes for Low Road Oakley and project funding. Two schemes had been suggested following a site visit:
- i. creation of 40 mph buffer zone with improved signage and additional road markings
- ii. to make 30 mph more visible through signage and 'repeaters'.

The Chairman asked councillors if they were minded to proceed with both suggestions or if there was one that they considered would be a preferable option. Cllr Fleming confirmed that she would be able to offer funding and that the Council should also apply for District CIL towards the project. Both District and County Councillor thought that the project would be acceptable for the District CIL funding. The total was approximately £23k for both projects. If an application was submitted it was envisaged it would take two months. If the Parish Council were to proceed with the schemes, Suffolk Highways would need to understand that any instruction was conditional on District CIL funding and if the funding was not forthcoming the work would not be able to proceed. Cllr Burn would advise the Clerk who to contact in MSDC Infrastructure Team to further discuss the CIL bid and Cllr Fleming was very confident that MSDC would be able to fund this scheme with some support from her County Council Highways budget. If quotes could not be guaranteed until CIL funding was achieved, the Parish Council would have to consider the matter again. The Parish Council were in agreement that if funding could be secured, they would proceed with both schemes outlined above, however, if this was not possible consideration would need to be given to which scheme was most best value for and likely to be most effective.

Support for the Environmental Protection Officer comments and request clarity on the question of disposal of horse manure and whether any lighting is proposed for the turnout area. The proposed timber-clad hay storage barn is something of a fire risk and so siting the stables/hay store at the opposite (southern) end of the turnout area away from existing outbuildings and oil tanks might

- a. The plan would be going before South Norfolk Council next week with the anticipation that it would progress to Regulation 16 consultation. Following this consultation period the plan would then be submitted to the Planning Inspector and then public referendum.
- b. The Clerk would supply statutory consultees with details of the Regulation 16 consultation when it was ready to proceed.
- 8. Asset Management
- a. It was noted that the installation of a defibrillator in the telephone kiosk in Lower Oakley had been completed. Consideration of a further defibrillator in the western side of Brome was considered. Sites would be assessed before the next meeting.
- b. Jubilee Garden there was no update available. It was agreed to defer this item to the next meeting.
 c. Bird Boxes Cllr Prior would report at the next meeting to how installing bird boxes at various locations

in the village may be achieved.

- d. Village Hall expenditure to date on the refurbishment of the Hall, as funded by the Parish Council, was noted as £4906 (nett) in the 2021/22 financial year and £4796 (nett) to date in the current 2022/23 financial year. The Village Hall Committee would like to request financial support for a store at the rear of the building and further information and quotations would be provided at the next meeting. Regarding the allocation of CIL funds it was noted to date that from the Parish Council's current CIL balance of £18,358, £240 had been spent on a village hall project (windows) and £2215 on the Lower Oakley defibrillator. It was agreed the expenditure to date in this financial year for Village Hall improvements (£4,796 as reported earlier) would be taken from CIL funds.
- 10. Finance and Governance
- a. The current financial position was noted as £18,603 in the current account and £3,953 in the business save account. It was noted that Cllr Broughton needed to be provided with the document to carry out the bank reconciliations.
